Engineer's Report:

- P. Gross reported contractors continue to form and pour concrete for Ox Ditches and Clarifiers. The work in the office will begin in the next couple of weeks, S. Simon will be relocating her office to Buchart Horn's construction until the renovations are complete.

Plant Operator's Report:

- S. Simon submitted the plant operations report for December 2009. No violations occurred in the month of December for the 19th consecutive month. There were five emergency call outs in November.
- S. Simon reported that an overflow condition occurred on 12/26/2009, PADEP was contacted and visited the site to inspect the overflow. The area was treated with lime per the request of PADEP. A letter was set to PADEP stating the new processes that are being implemented to help avoid these situations in the future.
