R. Stone made a motion to approve the July minutes. The motion was seconded by J. Miller and unanimously approved.

# **Financial Report:**

## **Engineer's Report:**

P. Gross provided an Engineer's Report for July which is filed with these minutes and incorporated herein by reference. P. Gross provided an update on the status of the requisitions. Due to the insufficient remaining balance on the 2015 bond (for the Miscellaneous Improvements project), some of the requisitions approved for July had to be revised/rescinded and were reissued at the August meeting. The following requisitions were rescinded despite approval at the July meeting:

- DT-16 in the amount of \$21,455.50 to Buchart Horn for engineering fees for the Misc. Upgrade Project (this is the 26<sup>th</sup> draw on the 2015 bond fund)
- DT-Mechanical-1 in the amount of \$55,311.48 to Garden Spot Mechanical for mechanical contracting services for the Misc. Upgrade Project (this is the 28<sup>th</sup> draw on the 2015 bond fund)
- DT-Mechanical-2 in the amount of \$35,874.72 to Garden Spot Mechanical for mechanical contracting services for the Misc. Upgrade Project (this is the 29<sup>th</sup> draw on the 2015 bond fund)
- DT-General-5 in the amount of \$143,675.15 to Heisey Mechanical, LTD for general contractor services for the Misc. Upgrade Project (this is the 30<sup>th</sup> draw on the 2015 bond fund)

R. Stone made a motion to rescind the above approved requisitions. The motion was seconded by J. Miller and unanimously approved.

P. Gross reported that the Miscellaneous Improvement Project will be completed before the September 26, 2017 waste water treatment facility open houses.

M. Fleming gave a report on the relining work in the Andover development and E.K. Services will be working on the line in Emigs Mill Road.
