SOLICITOR'S REPORT by Attorney Charles Rausch

Approve Boyd Hess Deed of Dedication

Attorney Rausch informed the Dover Township Board of Supervisors the Boyd Hess Deed of Dedication conveys a twenty-two (22) acre parcel from Terra Vista. The twenty-two (22) acres of land have been recorded and the mortgage has been released per Attorney Rausch.

Motion by C. Richards and seconded by S. Parthree to approve the Boyd Hess Deed of Dedication, as presented. **Passed** with 4 ayes

Approval to Permit the Property Owner of 3250 Staunton Avenue to Place a Fence through a Jurisdictional Wetland

Attorney Rausch informed the Dover Township Board of Supervisors that the residents of 3250 Staunton Avenue in Dover Township desire to place a fence on their property thru a jurisdictional wetland. The permit meets all Dover Township permitting requirements and regulations; however, the Pennsylvania Department of Environmental Protection possess their own set of regulations. The residents of 3250 Staunton Avenue have agreed to enter into an agreement with Dover Township designating that they understand they are taking their chances with the Pennsylvania Department of Environmental Protection and that Dover Township will not hold any liability for their actions.

Board consensus was reached, and it was collectively decided to approve the permit requested for the property owner of 3250 Staunton Avenue to place a fence through a jurisdictional wetland and for the drafting of an agreement with the residents of 3250 Staunton Avenue regarding Dover Township will not hold any liability for the residents of 3250 Staunton Avenue's action.

Fountain Rock Development Surety Update

Attorney Rausch informed the Dover Township Board of Supervisors that he has contacted the Surety company for Fountain Rock Development. Attorney Rausch received initial

communication from the Fountain Rock Development's Lexon Surety in May of 2018. Attorney Rausch requested further necessary information and he has not heard word from Lexon Surety since that time. Attorney Rausch addressed concerns he has regarding the lack of communication from Lexon Surety. It was reviewed that the Township retains a years' time frame in which the Township can collect the necessary financial surety. Attorney Rausch would like Board approval to institute legal action in order to obtain the necessary financial means for the bonds required from Lexon Surety.

Motion by S. Parthree and seconded by M. Cashman to approve authorization for; Dover Township Solicitor Charles Rausch, to institute legal proceedings to collect surety on the bond for the Fountain Rock Development, as presented. **Passed** with 4 ayes

Letter from Representative Seth Grove's Office Regarding Priority of State Road Improvements within Dover Township

A letter from State Representative Seth Grove's Office regarding the priority of State Road Improvements within Dover Township was provided to the Board of Supervisors. A list is to be generated, consisting of state roads that need to be paved or otherwise improved, in order to reply to Representative Grove's request.

M. Fleming offered some of his examples of state roads that need improved. M. Fleming

offered the following suggestions for roadways needing improvement: 1.) Carlisle Road and Church Road Traffic Signalization, 2.) Traffic Circle near Hake's Store, 3.) Intersection of Bull Road and Nursery Road Relating to Complaints, 4.) Big Mount Road and Pine Hill Road Relating to Complaints, 5.) Colonial Road Regarding Paving.

Board Consensus was reached, and it was collectively determined to have the Public Works Director; Mr. Michael Fleming, to create a stacked listing of the priority state roadways needing improved within Dover Township. The Board of Supervisors will revisit this listing during the next scheduled Board of Supervisors meeting.

Approval of the Professional Services Contract with HRG for the Comprehensive Plan Update

The Board of Supervisors were provided with the Professional Services Contract with HRG for the Comprehensive Plan Update. The contract was drafted by the York County Planning Commission in compliance with the federal government's requirements for Community Development Block Grant Projects.

Motion by C. Richards and seconded by S. Parthree to approve the Professional Services Contract with HRG for the Comprehensive Plan Update, as presented. **Passed** with 4 ayes

Approval of an Agreement by and between Dover Township and Dover Area School District Concerning the use of Eagle View Park for Cross Country Team Practices

The Dover Area School District has requested Dover Township's cooperation to allow the Golf Course Property to be utilized for the cross-country team to be used for practice only during the 2018 cross-country season. The proposed agreement has been reviewed by the Township Solicitor.

Motion by S. Parthree and seconded by M. Cashman to approve an Agreement by and between Dover Township and Dover Area School District concerning the use of Eagle View Park for Cross Country Team Practices, as presented. **Passed** with 4 ayes

Approval of Resolution No. 2018-23 Establishing New Guidelines regarding Accepting Recyclable Items in the Dover Township Recycling Program

Recent changes in regulations regarding acceptable materials in China, Penn Waste and other trash haulers have had to change what items are acceptable in residential recycling programs. These changes will affect Dover Township's recycling program. Therefore, these changes are now being reflected in the amended Resolution 2018-23 to establish the new guidelines regarding acceptable recyclable items in the Dover Township recycling program.
