 - Note: These properties are primarily located in Paradise & Jackson Township. They were enrolled in Ag Security in 1990 & 2013 in their respective Townships, but a small portion of the farmland is also located in Dover Township and was never entered. Both farms are applying for Preservation & Conservation Easements and the smaller portions in Dover Township need to be added to finalize their applications.
